#### Invitation

On behalf of the Illinois Department of Public Health's Office of Women's Health and Family Service (OWHFS), we would like to extend an invitation to attend the second Illinois Maternal Health Summit. The purpose of the Summit is to convene maternal health stakeholders from around the state to identify opportunities to reduce disparities in maternal health outcomes and coordinate efforts to improve maternal health in Illinois.

Reaching Illinois women and families is at the core of every activity conducted by the OWHFS. OWHFS will be releasing the third Illinois Maternal Morbidity and Mortality report in October 2023. This report identifies statewide trends in maternal deaths and provides recommendations to help prevent maternal mortality. The Summit will serve as a time for maternal health stakeholders including advocates, providers, community members, and policymakers to come together and align efforts.

## **Program Objective**

Learn about factors contributing to maternal mortality in Illinois, discuss recommendations generated by the Illinois Maternal Mortality Review Committees, and develop specific action steps to implement programs and policies to improve outcomes for women and families across the state of Illinois.
