Purpose, to amend the bylaws of the SGA.

Whereas, currently, there are over 66 student organizations at the College and only 4 members of the Allocations Committee, excluding Treasurer Rozansky.

Whereas, currently, this bylaw is not enforced.

Whereas, this bylaw is inefficient, seeing that each member is supposed to act as a liaison to one of our many student organizations, in order to oversee proper use of allocated funds and better our relationship with the few participating organizations.

Therefore, BE IT ENACTED BY THE SENATE OF THE STUDENT GOVERNMENT ASSOCIATION IN REGULAR SESSION ASSEMBLED, THE FOLLOWING:

Section I: Strike section 1400.003a from the bylaws, which currently reads, “Each member of allocations committee shall be assigned to an on-campus organization as liaisons of the Student Government Association, and be responsible for attending the meetings of said organization. These liaisons will help to ensure that funding is allocated appropriately as well as to encourage collaboration of on campus organizations. Within 24 hours of

1 the meeting, a typed document shall be presented to the treasurer with
2 information on what has occurred during the meeting.

3 **Section II:** THIS BILL SHALL TAKE EFFECT (UPON PASSAGE) BY THE
4 STUDENT SENATE SITTING IN GENERAL ASSEMBLY AND THE
5 SIGNATURE OF THE STUDENT BODY PRESIDENT.
