NATION ACCLAIMS UNION VICTORY IN BOSTON

At the Boston Arena, site selected by the State Labor Relations Board for the history making election of a Bargaining Agent for the teachers of Boston, from the seven A.M. opening time of the polls till the final votes were tallied at ten P.M., Boston's teachers firmly endorsed the principle of Collective Bargaining by a resounding 66 to 1. Opposing 2718 votes cast naming a choice of agent, only 41 votes were for the "no agent" option. Recurrent waves of teachers descended upon the polls prior to the opening of schools in the morning, following the dismissals in the afternoon, the ending of Home and School sessions for Junior High Schools throughout the system, and finally through the gloom and confusion of the paralyzing and mysterious power failure of November 9, 1965.

Emergency lighting of the polling place. supplemented by the eerie flicker of household candles, planted on the tables provided for the commissioners and poll workers heightened a bizarre atmosphere, already almost too tense for the weary onlookers and workers.

The one emotion not visible at any time during the long day was complacency. The air of expectancy was compared by more than one teacher to that of a hospital waiting room, thronged with prospective fathers. To continue the not inapt analogy, we joyfully report a safe delivery, congratulate the proud parents, and predict a most auspicious future for this long awaited infant.

AFT DOUBLES LIABILITY INSURANCE PROTECTION

Occupational liability insurance protection has been doubled in value this school year, it has been announced by the national office of the American Federation of Teachers, AFL-CIO.

The new protection for members in participating locals is now \$100.000.

This protects the teacher against liability suits brought by parents. In spite of everything, injuries occur in the classroom, laboratories, on the athletic field and on field trips. The AFT teacher has coverage for all claims for civil damages arising out of school-connected professional activities including damage suits where the teacher is accused of assault and battery.

According to Albert Wohlers, of Chicago, who is administrator of the AFT Insurance Plans, there are now some 100 cases pending.

In each case, expert legal counsel is provided for the affected teacher free of any fees. No teacher covered has lost a case in court.

The insurance policy is underwritten by Lloyds of London, one of the world's most famous reliable liability insurance underwriters.

In addition, the AFT makes available to its 114,000 members special group rates on these insurance policies:

- Loss of Speech, Sight or Hearing . . . protection up to \$25,000.
- Life Insurance . . . term insurance at low group rates.
- Disability Insurance . . . pays benefits in case of illness or accident.
- Accidental Death Insurance . . . pays \$1,000 benefit on on a participating local basis.
