

### Friday's Featured Speakers (in alphabetical order)



#### Bill McKibben (Third Act)

Bill McKibben is a renowned environmentalist, author, and journalist, best known for his book The End of Nature (1989), the first publication for a general audience on climate change. He is the founder of Third Act, a nonprofit engaging people over 60 in climate activism, and helped co-found 350.org, the first global grassroots climate campaign. McKibben has authored over twenty books and countless articles, and is recognized as one of the world's most influential environmental advocates, regularly speaking at major institutions and leading international campaigns for climate justice.



#### **Emily Atkin (HEATED)**

Emily Atkin is the author and founder of HEATED, a weekly newsletter focused on accountability reporting and analysis of the climate crisis. She is also a contributing columnist for MSNBC. Previously, Emily was a climate staff writer at The New Republic and deputy climate editor at ThinkProgress, with her work featured in major outlets like Newsweek, Slate, and Mother Jones. Her journalism is driven by a commitment to uncover stories that matter, inspired by her mentor, investigative journalist Wayne Barrett.



## Jamie Taylor (Vice President for Corporate Affairs at Protagonist Therapeutics) - Moderator

Jami Taylor is Senior Vice President of Investor Relations at Coherus BioSciences, a biotechnology firm based in Redwood City, California. She serves on boards and advises early-stage biotech companies in the San Francisco Bay Area and San Diego. With over a decade of experience, Jami is a distinguished lecturer on Investor Relations topics at top universities such as MIT Sloan, Harvard, and Yale. She holds an MBA from Northwestern's Kellogg School of Management, a master's from Harvard, and a BA with Distinction from the University of Virginia, and is an Investor Relations Charter holder.



## Kai Chen (Yale Associate Professor in Environmental Health Sciences)

Dr. Kai Chen is an Associate Professor of Epidemiology (Environmental Health Sciences) at Yale School of Public Health and Co-Faculty Director of the Yale Center on Climate Change and Health. He earned his PhD in Environmental Science and Engineering from Nanjing University and has held fellowships at Columbia University and Helmholtz Zentrum München. Dr. Chen's research focuses on how climate change and air pollution impact human health, employing interdisciplinary approaches in exposure assessment and environmental epidemiology, with studies conducted across China, Europe, and the United States.

## Latha Swamy (Director of Food System Policy, City of New Haven)

Latha Swamy is the Director of Food System Policy for the City of New Haven, CT, where she supports community-led efforts to build environmentally sustainable and socially just food systems. She also serves as Senior Advisor to Dr. Ernesto Zedillo at Yale's Center for the Study of Globalization, and is active internationally on issues related to environmental degradation, health, and agriculture. Latha holds a Master's of Environmental Management from Yale, and has also trained in urban farming and food justice practices.



## Rick Lopes (Connecticut State Senator and Chair, Senate Environment Committee)

Rick Lopes is a Connecticut State Senator representing the 6th district, encompassing Berlin, New Britain, and parts of Farmington. He has a bachelor's degree in English literature and sociology and a master's in social work from the University of Connecticut. Lopes serves as Co-Chair of the Environment Committee and Vice Chair of the Transportation Committee. He has a background in community organizing, housing coordination, and vocational counseling, with a strong commitment to environmental sustainability and social equity within the state legislature.



#### **Thomas Pogge**

Having received his PhD in philosophy from Harvard, Thomas Pogge is Leitner Professor of Philosophy and International Affairs and founding Director of the Yale Global Justice Program. He is a member of the Norwegian Academy of Science as well as co-founder of Academics Stand Against Poverty (ASAP), an international network aiming to enhance the impact of scholars, teachers and students on global poverty. Vernon Loeb is the Executive Editor of Inside Climate News, a leading non-profit newsroom dedicated to environmental journalism. He has a distinguished career as a reporter, foreign correspondent, and editor, having worked at The Atlantic, Los Angeles Times, The Philadelphia Inquirer, The Washington Post, and Houston Chronicle. Loeb covered major events such as the Tiananmen Square uprising and wars in Iraq and Afghanistan, and under his editorial leadership, the publications he worked with received multiple Pulitzer Prize nominations and awards. He brings decades of experience in political and investigative journalism to his current role focused on climate and environmental issues.

### Saturday Featured Speakers (in alphabetical order)



#### **Branko Milanovic**

Branko Milanovic is a leading economist specializing in economic inequality. After serving as lead economist in the World Bank's Research Department for nearly 20 years, he is now a Professor of Economics at the City University of New York Graduate Center. Milanovic holds a Ph.D. in economics from the University of Belgrade and has written extensively on income distribution both within and between countries.



#### **Dianne Calvi**

Dianne Calvi is the President and CEO of Village Enterprise, a nonprofit dedicated to ending extreme poverty in rural Africa through entrepreneurship and innovation. Since joining the organization in 2010, she has led its expansion across seven countries, implemented pioneering funding models, and overseen rigorous impact evaluations. Dianne also serves on the board of directors of InterAction and the National Advisory Board for Stanford University's Haas Center for Public Service.



#### **Isabel Ortiz**

Isabel Ortiz is Director of Global Social Justice, a Geneva-based think tank, and heads the Global Social Justice Program at Joseph Stiglitz's Initiative for Policy Dialogue at Columbia University. She served as Director of the Social Protection Department at the United Nations International Labour Organization (ILO) from 2013 to 2019 and previously held senior roles at UNICEF and the UN Department of Economic and Social Affairs.



#### Michael Gerrard

Michael B. Gerrard is the Andrew Sabin Professor of Professional Practice at Columbia Law School and the founder and faculty director of the Sabin Center for Climate Change Law. He teaches environmental law, climate change law, and energy regulation. Prior to joining Columbia in 2009, he practiced environmental law in New York for nearly three decades, including as partner in charge of Arnold & Porter's New York office. Gerrard has led major legal efforts on climate change policy, chaired numerous environmental law committees, and authored several influential books and columns on environmental law and climate regulation.

#### Sari Nuseibeh

Sari Nusseibeh is a Palestinian professor of philosophy and former president of the Al-Quds University in Jerusalem. Until December 2002, he was the representative of the Palestinian National Authority in that city. Often categorized as a moderate, he has advocated a one-state solution: a single, democratic, secular, binational state in which equality before the law, universal suffrage, and full citizenship are guaranteed for all inhabitants, irrespective of their ethnicity or religion.



#### Yon Fernández-de-Larrinoa

Yon Fernández-de-Larrinoa is Head of the Indigenous Peoples Unit at the FAO. An agricultural economist from UAM Madrid with a MABD in entitlements and food security, he has led major initiatives on indigenous food systems and coordinated emergency relief operations globally. He designed the FAO Manual on Free, Prior and Informed Consent and co-founded the FAO Pastoralists Knowledge Hub.

#### **Aanchal Seth**

Aanchal Seth is a Research Scholar at Panjab University, Chandigarh, India. Her work focuses on tribal rights to forests, with a special emphasis on the remote and ecologically sensitive regions of Himachal Pradesh. Through her research, she seeks to understand the intersections of community livelihoods, forest governance, and indigenous rights in the Himalayan context



#### Adam Ploszka

Dr Adam Ploszka is an assistant professor at the Center for Human Rights, Faculty of Law and Administration of the University of Warsaw. Formerly associated with the European University Institute in Florence as a Max Weber Fellow. Adam is the author of several publications on human rights and constitutional law.



#### **Alberto Cimadamore**

Cimadamore is a researcher at the National Scientific and Technical Research Council of Argentina (IIEP UBA-CONICET) and Director of the Center for Sustainable Development (FCE-UNL).



#### Alexander waller

Alex has a doctorate in Renewable Energy Technology and Environmental Ethics Education. He is the Head of Science at St. Stephen's International School in Thailand and a Fellow of the Royal Society of Biology. Alex has written several papers and book chapters as well as co-editing a book Planetary Health and Bioethics.

Dr. Ali Fathollah-Nejad is a German-Iranian political scientist and founder/director of the Center for Middle East and Global Order (CMEG) in Berlin. Ali earned his PhD from SOAS, University of London, and has held fellowships at the Harvard Kennedy School, Brookings Institution, and American University of Beirut. An accomplished author and speaker, he has published extensively on Iran and international relations.

#### **Carol Cravero**

Carol is an Attorney-at-Law admitted to the Italian Bar and holds a joint PhD in Sustainable Public Procurement Law from the Universities of Turin and Paris Nanterre. She has served as a Legal Affairs Officer at the World Trade Organization and has advised governments on procurement reforms across Africa and the Middle East. As a certified OECD-MAPS assessor, she is currently conducting the public procurement assessment for Chad. A 2025–2026 Yale ASAP Fellow within the Global Justice Program, she is exploring the nexus of culture, sustainability and public procurement, with a particular focus on Indigenous traditional knowledge.



#### **Christopher Ryan Maboloc**

Dr. Christopher Ryan Maboloc is an Associate Professor at Ateneo de Davao University, the Philippines. He is the co-founder of the Social Ethics Society. In 2020, he was awarded the Public Intellectual Prize by the Philosophical Association of the Philippines as a recognition of his work and contribution to public discourse in the Philippines as a scholar.

Clautrida Mutabaruka is one of the prize winners of this year's Nelson Mandela Essay Prize Competition. Her work focuses on Indigenous Peacebuilding as a proactive approach to reducing conflict and displacement crises



#### **Danielle Denny**

Danielle Denny is a researcher at RCGI/USP, CCarbon/USP, and a Postdoctoral Fellow at ESALQ/USP. Specialised in sustainability with a JD in international environmental law, she focuses on climate governance and pasture restoration. She held visiting fellowships at Yale, UCL, and NUS, collaborated with ECLAC/UN, and is a lead author of GEO-7/UNEP and a contributor to the Climate Technology Progress Report (UNFCCC).



#### **Dominic Thomas-James**

Dominic Thomas-James is a Postdoctoral Research Associate at Fitzwilliam College, University of Cambridge, and a Global Justice Fellow at Yale University. He is also a Tutor in International Relations and International Development at the University of Cambridge Institute of Continuing Education, and a member of the Cambridge Centre for Criminal Justice. Mohammed Omer is a Scientific Assistant at the New Production Institute, University of the Federal Armed Forces Hamburg and a visiting doctoral researcher at the Judge Business School, University of Cambridge. His work explores how open source industrial machines can enable sustainable industrialization and expand access to manufacturing in low-resource settings. He focuses on participatory design, frugal innovation, and distributed manufacturing approaches.
