APPLICANT:

- The student researcher has a Bachelor of Arts degree with honours from the University of Waterloo with a major in psychology. She completed an undergraduate thesis, which she presented at two academic conferences. In addition, while the student researcher attended the University of Waterloo she was a research assistant under the direction of Dr. J. LaGuardia. The student researcher collaboratively developed study designs and ethics proposals on the proposed research. She administered protocol, data collection and entry, assessed fidelity of adherence, and monitored progress.
- For the majority of her attendance at Adler University, she has been employed full time in the Downtown East Side at the Salvation Army Harbour Light's male residential alcohol and

- The student researcher has read research exploring transtheoretical theory (DiClemente, 2003; Park, Tod, & Lavallee, 2012), happenstance theory (Krumboltz, 2009, 2011), Alcoholics Anonymous (Alcoholics Anonymous, 2012; Gomes & Hart, 2009), maintenance factors in recovery (Gubi & Marsden-Hughes, 2013; Moos & Moos, 2007), quality of work life (Martel & Dupis, 2006), and work in recovery (Blum & Roman, 1985; Doukas & Cullen, 2010; Slaymaker & Owen, 2006).
- The student researcher will be conducting the study in accordance with the requirements for the Master of Arts in Counselling Psychology program at Adler University.

RESEARCH TEAM:

- The student researcher's thesis advisor, Rosa Wu, Ph.D., R.Psych., is a registered psychologist in British Columbia. She has extensive experience with the narrative methodology, which she utilized to co-construct individual and common themes narratives for her doctoral dissertation.
- The student researcher's second reader, Dr. Danielle Duplassie, is a registered counsellor in British Columbia, the founder and director of The Shanti Counselling Centre. Dr. Duplassie has experience and knowledge of narrative research, and a long history of working with people with a wide range of addictions.

2. SUMMARY OF STUDY AND RECRUITMENT

2.1 A. Overview of Research Study (Maximum 300 words)

1) Purpose:

• To explore how attainment of and abstinence from alcohol and drugs, along with AA involvement, impacts the process of long-term abstinent Alcoholics Anonymous (AA) members' work journeys and quality of work life.

2) Research Questions:

- How has sobriety impacted long-term sober AA members' work experience?
- How has work experience impacted the sobriety of AA members with long-term sobriety?

3) Rationale:

 While the impact of alcoholism on a person's well-being and social interactions have been well documented (Beck, Wright, Newman, & Liese, 1993), the research that has been conducted on the work life of recovered alcoholics does not specifically address the longterm work experience of AA members with long-term sobriety and how it affects their life and sobriety.

- In addition, a gap in the human resource development literature exists regarding the issues relevant to recovery and alcoholism. Specifically, there is no research that examines how individuals with the recovered alcoholic identity successfully negotiate the challenges associated with the work environment (Gedro, Mercer, & Iodice, 2012).
- Unlike previous research, this study will focus on the work experience of AA members with long-term sobriety.

4) Objectives:

- Uncover how attainment of and abstinence from alcohol and drugs, along with AA involvement, impacts the work journey of AA members with long term sobriety.
- Identify those elements of AA participation, if any, which impact a person's work experience.
- Establish whether there are work aspects that have an impact on a person's recovery. Specifically, this study will identify the stigma- and work-related barriers recovered alcoholics faced, how they faced them, and how they dealt with them.

2.1 B. Summary of Research Procedures (Maximum 500 words)

• Qualitative narrative inquiry will be used because it provides participants with the opportunity to tell stories that connect past, present, and future selves in a manner most meaningful to their experience(s) (Riessman, 1993). These complete stories may lead to uncovering the interconnected relationship between sobriety and employment, which is a goal of this study.

Research steps:

- 1. Three participants will be recruited using snowball and convenience sampling techniques. AA members known by the student researcher and relevant organizations in Metro Vancouver will be given the Recruitment Poster (Appendix A) and asked to display the poster (see Appendix B). The Recruitment Poster will be posted on a Facebook page dedicated to the study, on www.craigslist.ca, and www.kijiji.ca. The research study's Facebook page will not be linked to the student researcher's personal Facebook page.
- 2. Individuals who respond to the poster will be sent a recruitment email (see Appendix C) that includes more information on the study.
- 3. To recruit an expert reviewer, the convenience sampling method will be used. An email (Appendix D) along with the Recruitment Poster (Appendix A) will be sent to mental health or human resource professionals who are known to this student researcher as having worked with the population under study.
- 4. Those that answer the recruitment email will be screened and informed about the study over the phone using the Initial Participant Contact Scripts (Appendices E-G). One peer reviewer

will be recruited from the potential participant list (see Appendix E).

- 5. Potential participants and reviewers who meet the study's criteria will be sent the appropriate Informed Consent Form (Appendices H-J) to review. Once the document has been signed, the interviews will be scheduled. This document will be reviewed and signed prior to all interviews.
- 6. At the initial audio-recorded in-person interview, the Informed Consent Form (Appendix H) and the Consent to Audio Tape Form (Appendix K) will be reviewed and participants will be asked to sign the form. This interview will use the Orienting Statement and Interview Guide (Appendix L). A second audio-recorded interview may be scheduled at the participant's request.
- 7. The audio-recorded interviews will be transcribed by the student researcher following Poland's (2003) approach.
- 8. Lieblich and colleagues' (1998) holistic-content analysis approach will be used to coconstruct the individual narratives for each participant based on the transcriptions.
- 9. Participants will be given their individual narrative to review before attending a validation interview. All validation interviews are unrecorded and may occur in-person or over the phone. The Validation Interview Guide Questions (Appendix M) will be used by the student researcher. The participants will be given the opportunity to modify the narrative to protect their confidentiality.
- 10. Lieblich and colleagues' (1998) categorical-content analysis approach will be used to coconstruct a common themes narrative.
- 11. Participants will review the common themes narrative before attending an additional validation interview to give their comments.
- 12. The peer reviewer and expert reviewer will be sent the common themes narrative to review prior to attending the validation interview. Their comments will be presented as validation checks in the results section of the study.

2.3 Inclusion Criteria

Inclusion Criteria for General Participants and the Peer Reviewer:

- Identifies as a recovered, recovering, abstinent, and/or sober alcoholic.
- Meets the diagnostic criteria for Alcohol Use Disorder as stated in the 5th edition of the Diagnostic Statistical Manual of Mental Disorders (DSM-V; American Psychiatric Association, 2013).
- Abstinent from alcohol and drugs for a minimum of 20 years.
- Identifies as a member of AA.
- Is an active participant of AA. An active member of AA is defined as one who attends approximately one meeting a week, has a home group, has a sponsor, does service, and does the steps.
- Between the ages of 37 and 75.
- Has worked full-time for a minimum of 1 year while drinking.
- Has worked full-time for a minimum of 10 years while being a sober active member of AA.
- Willing to speak about their alcohol-related, recovery, and work experience.
- Able to speak and read English.
- Comfortable completing 2 to 5 hours of interviews over a one-year period.

These inclusion criteria were selected because:

- Since one of the goals of this proposed study is to uncover challenges of negotiating the work environment as a recovered alcoholic, the qualifying participants must identify themselves as recovered alcoholics and meet the DSM-V criteria of Alcohol Use Disorder (American Psychiatric Association, 2013).
- Consistent with the aforementioned goal, participants must identify as members of AA and be abstinent from alcohol and drugs.
- Individuals with 20 years or more of sobriety have been classified as old-timers (Browenell, 2011). Lack of research exists on individuals with long-term sobriety (Gubi & Marsden, 2013).
- Full-time employment for 10 years during abstinence is required to increase the quantity of experience both in terms of work hours and work pressure, whether it is in job performance or exposure to a drinking environment. Gedro, Mercer & Iodice (2012) state that negotiating the workplace as a sober alcoholic is a lifelong challenge. Though 10 years is not a lifetime, it is a long time.
- The qualifications referring to AA membership and active membership while working will help ensure that the work experience of active AA members will be studied.
- The reasoning behind requiring the experience of working while under the influence is so that participants can speak to the contrast between working while drinking and working while in recovery.

- The age range was determined by considering the minimum legal age to work (Ministry of Labour Employment Standards Branch Province of British Columbia, 2008), retirement age (Government of Canada, 2015), and the specific requirements of this study.
- Requiring participants to be comfortable to speak on the topic helps ensure that the information shared is detailed and authentic so as to result in the validity of the research.
- The English reading and speaking requirement will ensure that participants can thoroughly answer the research questions in order to co-construct accurate and meaningful narratives that are rich in detail.
- Participants need to have the time and stamina available to complete up to five hours of interviews over one year.

*Note: the peer reviewer assists with validation of the study's data. In order for them to provide authentic validation they need to meet the same criteria to be included in the study.

Inclusion Criteria for the Expert Reviewer:

- Have professional expertise working with employed individuals in recovery from alcohol use disorder.
- Have relevant education, research or teaching experience.
- Speak and read English.
- Are comfortable reading a story for about 1 hour and completing a 30-minute interview over a 12-month period.

2.4 Exclusion Criteria

Exclusion Criteria for General Participants and the Peer Reviewer:

- Participants who do not meet the inclusion criteria.
- Any former clients of the researcher.
- Any former fellow classmates of the researcher.
- AA members who are part of the student researcher's immediate support group (which is made up of a sponsor, sponsees, close AA confidants, and AA home group). Specifically, individuals who the student researcher has associated with outside of AA meetings or functions will be excluded from the study.

These criteria were selected because:

- Interviewing a heterogeneous mix of people allows for a diverse collection of stories, experience, depth, and meaning to ensure the goals of this research are met.
- Former clients and classmates of the researcher and the researcher's AA immediate support group are excluded so as to avoid the possibility of dual relationships.

2.5 Recruitment

• AA members known by this student researcher will be provided with the Recruitment Poster (Appendix A) and will be requested to pass on the information to people they believe may qualify for this study (see Appendix B). The Recruitment Poster (Appendix A) will be

provided by: 1) private email using (email)2) by private message via the student researcher's private facebook account, 3) requesting the email via phone call or text by stating "I am seeking participants to participate in a study on the work experience of AA members with long-term sobriety. Please provide me your email address if you are will to pass on information on the study, that I email you, to people you know who may be interested in participating.", and/or 4) face-to-face (either by chance or scheduled encounter)."

- The Recruitment Poster (Appendix A) and the Recruitment Inquiry Letter (Appendix B) will be emailed or given in person to community centers and churches in Metro Vancouver where AA meetings are held (e.g. the Alano Club, the Vancouver Recovery Club, and the West End Community Center), relevant counseling and service centres (e.g. Three Bridges, Raven Song), as well as local libraries and coffee shops in Metro Vancouver. If permission is granted by these organizations, participants will be recruited through the use of the Recruitment Poster (Appendix A), which could be displayed on-site at these organizations or on their websites or handed out in print from or emailed to anyone who may be interested.
- The Recruitment Poster (Appendix A) will also be posted on the research project's Facebook page dedicated to the study and general listing sites including www.craigslist.ca and www.kijiji.ca in order to attract additional attention to the study due to the unique requirements necessary for participation in this study. The advertisements will only display the student researcher's email address as a form of initial contact information. Postings will be created and managed by the student researcher only. These postings will act as a form of advertisement for potential participation in the study. Potential participants will be asked to inquire further via email to the email address provided by the student researcher. Potential participants will not be required, nor will be able, to provide any personal information including comments on the research project's Facebook page or on general listing sites.
- With regard to the research project's Facebook page, potential participants will be asked not to reply to postings on the research project's Facebook page. Friends and colleagues of the student researcher may also post a link to the research project's Facebook page on their personal Facebook profiles to increase the number of people who may view the page. Individuals may choose to "like" the page; however, people will not be able to see who has otherwise viewed the page or chosen to participate in the study. The research project' Facebook page security settings will only allow the student researcher to post on the page (i.e Settings-Timeline and Tagging Settings-Who can post on my timeline?-Only me).
- Individuals who have emailed their interest in participating in the current study will be sent a recruitment email (see Appendix C) that includes more information on the study.
- To recruit the expert reviewer, emails will be sent to mental health or human resource professionals who are known to this researcher as having worked with the population under study (see Appendix D).
- The student researcher will reply to the potential participants' and reviewers' emails to set up a telephone screening appointment and/or answer any questions posed by potential participants and reviewers who contact the student researcher via email. The telephone screening appointment will utilize the Initial Participant Contact Scripts (Appendices E-G), which takes participants and reviewers through the inclusion and exclusion criteria for the study as well as the purpose and process of the research.
- Once three participants have been chosen to participate in the study, the remaining potential participants will be notified and asked if they would like to be placed on a wait-list in the event one or more additional participants are required for the study to achieve

comprehensiveness or they are interested in becoming a peer reviewer (see Appendix E). All identifying materials, including contact information, for the individuals who did not meet criteria for participation in the study will be destroyed or erased as soon as it is certain that they will be unable to participate in the research.

2.7 External Approvals

Outline how you will contact and then obtain external approval from institutions or organizations, including Aboriginal communities or international sites. - The student researcher contacted Alcoholics Anonymous regarding the solicitation of AA members to participate in this study. An AA general service staff member suggested to avoid solicitation of participants at AA meetings. In addition, it was noted that participation by AA members was at the individual members' discretion and that anonymity was of utmost importance (Racy Joseph, personal communication, January 22, 2015).
- The student researcher will seek external approval from community centres and churches in Metro Vancouver where AA meetings are held (e.g. the Alano Club, the Vancouver Recovery Club, and the West End Community Center), relevant counseling and service centres (e.g. Three Bridges, Raven Song), as well as local libraries and coffee shops in Metro Vancouver.

The process of gaining external approval will involve:

• Sending the Recruitment Inquiry Poster (Appendix A) and Recruitment Letter (Appendix B) by email or in-person to the administrative person(s) of the relevant churches, community centres, counselling and mental health centres, libraries, and coffee shops in Metro Vancouver. The Recruitment Inquiry Letter (Appendix B) asks interested organizations to let the student researcher know about any formal guidelines, requirements, or processes that would require the student researcher's attention in order to obtain approval. The letter (Appendix B) includes a request that the Recruitment Poster (Appendix A) be displayed onsite and/or online. The letter (see Appendix B) also includes a suggestion that the organization could email and/or hand out in print form the poster (see Appendix A) to individuals who may be interested in participating.

2.8 Number of Participants

• Three participants will be enrolled in the study to share their experience in one or two initial interviews and to provide feedback in two validation interviews.

- One expert reviewer and one peer reviewer will also be part of this study to provide insight (discussed in detail below).
- **Peer Reviewer:** This person will be required to meet the inclusion and exclusion criteria for the study. The peer reviewer will be an individual who contacts the student researcher after three qualified general participants have been obtained. At this time, the individual will be given the option of being a peer reviewer for the study. If the individual declines they will be given the option to be on a waitlist in the event that alternative or additional participant(s) are required. The student researcher will clearly explain that the role of the peer reviewer is different from that of the three participants.
- The peer reviewer will review the common themes narrative for approximately up to 1 hour after it has been reviewed by the participants. The peer reviewer will provide insight by answering guided questions posed by the student researcher (see Appendix M: Validation Interview Guide Questions, sub-section: Guide Questions for the Validation Interview with Peer and Expert Reviewers) during one 30-minute interview up to one year after providing consent to participate in the study. By reviewing the common themes narrative, the peer reviewer offers important information that provides a validity check in narrative research (Lieblich, Tuval-Mashiach, & Zilber, 1998). While the validation interviews for participants ensure that the common themes accurately reflects the participants' personal experience(s), the validation interview for the peer reviewer gathers information from the general perspective of long-term sober AA members' work experience. The peer reviewer may speak to whether or not the population being studied as a whole might experience some of the themes that are co- constructed in the research.
- Expert Reviewer: This person will be an individual in the community who is known to the student researcher as having professional expertise working with employed individuals in recovery from alcohol use disorder (see Appendix D). They will have a relevant education, research, or teaching experience, and will be able to read and speak in English. They will review the common themes narrative and provide insight by answering guided questions posed by the student researcher (see Appendix M: Validation Interview Guide Questions, sub-section: Guide Questions for the Validation Interview with Peer and Expert Reviewers). They will need to be comfortable reading a story for approximately up to 1 hour and completing one 30-minute interview up to one year after providing consent to participate in the study.

- In the past, this student researcher was working full time at the Salvation Army Harbour Light's residential treatment facility (currently on leave of absence). In the past, this student researcher was affiliated with Living Systems as a practicum student. Though the student researcher has completed all classes at Adler University, she is still enrolled in the thesis courses. In addition, the student researcher is a member of Alcoholics Anonymous and regularly attends AA meetings.
- In order to manage potential dual relationships the student researcher will ask all potential participants in the Initial Participant Contact Script (Appendix E) how they found out about the study and, if applicable, whether or not they are affiliated with Adler University, Living Systems and/or Salvation Army Harbour Light.  - O The student researcher's membership in AA is addressed in the Initial Participant Contact Script (Appendix E) and in the Informed Consent (Appendices H & I) by including the following "It is important to note that the student researcher is also an AA member. A dual relationship may exist because of the two roles the student researcher has as a student researcher and AA member. As such, the details of the

4. RISK LEVEL and RISK MANAGEMENT

4.1 Determining Level of Risk

Minimal

Rationale:

- Participants will be informed that they can talk about as much or as little as they feel comfortable with. Thus, for the most part, the interviews will be guided by the participants themselves in response to the research questions posed by the student researcher. Participants will only be asked to discuss experiences they encountered in their day-to-day lives such as their experience navigating work without the use of alcohol. As such, participants will only be discussing areas of their work experience that they are comfortable with and areas that they would most commonly want to share with others when reflecting on their work journey both in and out of recovery.
- Consistent with the experience and activities of their daily lives, participants are asked to share about their experience. At AA meetings, members regularly share their past and present experiences, which may involve intense circumstances and emotions. Therefore, AA members are used to accepting the risk of sharing personal details of their lives with others. This study would represent a minimal increase, if any, in such risk. Since the interviews are not AA meetings, the student researcher will remain in the researcher role by engaging in behaviours associated with managing risks (see section 4.2 Description and Management of Risks) such as informing participants of the purpose of the research, directing participants to the reference list of professionals on the informed consent form, and reminding participants of their support group.
- Only minimal probing questions will be asked by the student researcher in the event that particular aspects of the research questions have not yet been covered.

- The peer and expert reviewers will be asked only to reflect and discuss the common themes narrative, which is based on the common themes in all participants' stories.
- Participants and the reviewer have the AA program and associated support structure in place to rely on when stress is experienced.

4.2 Description and Management of Risks

Describe what is known about the risks (harm) of participating in the proposed research and any possible vulnerability that needs to be considered. Indicate how you will address these risks. Risks to participants and reviewers:

• Through participating in the research study and disclosing personal information, participants and reviewers may encounter a minimal risk of experiencing stress, discomfort, or emotional reactions (Kvale & Brinkmann, 2009). Although participants and reviewers are asked to share only information that they are comfortable disclosing, some participants may experience stress, discomfort, and/or emotional reactions through the process of reflecting on particular past experiences and/or developing new understandings of themselves (Kvale & Brinkmann, 2009).

Management of risks:

- Informing participants and reviewers of their rights to: a) withdraw from the study at any time, b) take breaks during the interviews, c) ask to reschedule the interviews for another time, d) ask that the audio recording device be paused or turned off (for the initial interview only since this is the only interview that is audio-recorded), and e) withdraw their data from the study up to one month after their initial interview(s) have taken place (or up to one week after the validation interviews for the expert and peer reviewers). (Kvale and Brinkmann, 2009).
- All participants and reviewers will be notified in the Informed Consent Form (Appendices H-J) that interviews are not meant to provide personal counselling. However, given the fact that all participants and reviewers encounter a small risk of experiencing stress through participation in the study, a list of counselling services is included as part of the consent form (see Appendices H-J). They will be encouraged to contact the organizations on this resource list should they experience significant distress or wish to explore experiences that arose from the research process.
- Since one of the inclusion criteria is active participation in AA, the participants and peer reviewer have support (e.g. AA meetings, sponsor, other AA members) if needed.
- Making sure that participants and reviewers are fully informed regarding the purpose of the study, the basic research design, the previously mentioned potential risks of participation, and the storage of confidential data before their first interview takes place (Kvale and Brinkmann, 2009).
- Building research-appropriate rapport with and providing a safe, non-judgmental environment for participants to share their stories and experiences without coercion (Kvale and Brinkmann, 2009).

• As a risk management strategy, this study will be retrospective in nature and participants in the study will be asked to share and think back to their work experience in and out of recovery. Moreover, as part of the inclusion criteria for the study, participants and the peer reviewer must be comfortable to speak about their work experience. The expert reviewer must be comfortable to speak about their experience working with the employed recovered alcoholic population.

4.3 Anonymity and Confidentiality

- When potential participants and reviewers initially contact the student researcher, their contact information will be written on a paper copy of the Initial Participant Contact Scripts (Appendices E-G). This document will be stored in a locked filing cabinet at the student researcher's place of residence during the study and for five years after the study's completion. The Informed Consent Forms (Appendices H-J) and Consent to Audio Tape Form (Appendix K) will also be stored securely in the same locked filing cabinet at the student researcher's place of residence during the study and for five years after the study's completion.
- Audio recordings will only be transcribed by the researcher in a private space at the student researcher's home in order to reduce the risk that a person outside of the study might recognize participant-identifying information in a public setting. Electronic audio recordings and transcriptions will be stored in computerized files on password protected USB drives and stored in a locked filing cabinet at the student researcher's place of residence both during and after the research study. Only the student researcher and her thesis advisor will have access to the audio recordings and transcriptions.
- Participants and reviewers will be asked to adopt a pseudonym for the purposes of the study, which will be referred to during the interview process. The participants' pseudonym will also be used in all transcriptions and narratives. Participants' and reviewers' real names or initials will not appear in any versions of the completed study. The participants' real names will only be connected to their chosen pseudonyms on the Consent to Audio Tape Form (Appendix K). The peer reviewer and expert reviewers' real names will only be connected to their chosen pseudonyms on the Informed Consent Forms (Appendices I-J). All signed forms will be stored securely in a locked filing cabinet in the student researcher's place of residence during and after the completion of the study.

may be able to identify participants based on direct quotes or personal anecdotes shared in their interview(s). Participants will be made aware of this possibility in the Informed Consent Form (Appendix H) and they will have the opportunity to tell the student researcher if they wish to remove or alter any potentially identifying direct quotes or personal anecdotes in their personal narratives or in the collective narrative.

• Though personal identification is less likely for the reviewers, they will also be made aware of this possibility in the Informed Consent Forms (Appendices I-J) and they will have the opportunity to tell the student researcher if they wish to remove or alter any potentially identifying direct quotes or personal anecdotes shared when reflecting on participants' collective narratives.

What, if any, limits to confidentiality are considerations in your research, what is your rationale for including them, and how will they be communicated to participants?

- Limits to confidentiality will exist if a participant and reviewer disclose abuse of a child or vulnerable adult, or of a clear risk of imminent harm towards herself or someone else in which case the student researcher would have a duty to report. In addition, if the researcher receives a court order or subpoena, she would be legally obligated to comply.
- The student researcher will orally review the confidentially agreement in the Informed Consent Forms (Appendices H-J) at the beginning of the first interview with participants and reviewers. The student researcher will remind participants of the limits to confidentiality and her obligation towards reporting at the beginning of any following interviews. The confidentiality section (Appendices H-J) reads as follows:

 <u>Limits to Confidentiality:</u> All identifying information from this study will be kept strictly confidential unless any of the following conditions are present:
 - A) If a child or vulnerable adult is at risk of abuse or neglect and is unable to seek help, or is in need of protection.
 - B) If you or another person is at clear risk of imminent harm.
 - C) If I am required to comply with a legal order such as a court order or subpoena.
 - D) Due to the small number of participants in this study, someone who reads published material about this study may identify you from information in the narratives. Due to the personal nature of the study, this risk is unavoidable. Thus, confidentiality cannot be guaranteed. To reduce this risk, pseudonyms will be used. You will be able to revise or remove parts of your individual narrative that may be too identifying. (Section D only appears in Appendix H.)

4.4 Benefits

The benefits to participation include:

- Experiencing validation, satisfaction and/or other positive emotions have been associated with sharing one's story (Lieblich et al., 1998). By engaging in self-reflexivity through participation in the research, participants may also develop new insights regarding the experience(s) that they chose to disclose and explore. For example participants may experience validation and/or positive emotions about their work experiences and/or recovery.
- The exploration of what participants take away from their experience in the research is a crucial component of the narrative methodology (Riesmann, 1993). Validation interviews will provide participants with an opportunity to reflect on how they may have benefited from participating in the research (see Appendix M: Validation Interview Guide Questions).
- Though they are not reveling as much personal in-depth information, reviewers are expected to receive the same aforementioned benefits as participants for the same reasons.
- The study may also benefit counsellors, other mental health professionals, and individuals working in human resources who work with employed recovered alcoholics. The study could provide valuable information to the mental health and human resource professions regarding the ways in which recovered alcoholics experience their career development and working environment.
- Pragmatic value or "the extent to which a particular study becomes the basis for others' work" (Riessman, 1993, p. 68) is an important validation criterion in the narrative methodology. Perhaps this study will lead to further research regarding work and recovery.
- The study could provide valuable information to mental health and human resource professions regarding the importance of intervention with issues that arise from being a recovered individual in the work force (e.g., stigma and pressure to partake in work events involving drinking).
- Lastly, the findings of this research may also be applied to new therapies, treatment plans, human resource policies, and/or ways of conceptualizing working with employed recovered alcoholics.

5.2 Time Requested of Participants

How much time will each participant be asked to dedicate to the research study?

- The total time requested of participants will be 2-5 hours.
- Participants will be invited to participate in one in-person, audio-recorded interview lasting approximately 60 120 minutes. This initial interview will utilize the Orienting Statement and Interview Guide (Appendix L). If any participant(s) express that they were unable to share their stories to a satisfactory level and wish to have more time, then an additional audio-recorded interview lasting approximately up to 60 minutes will be scheduled.
- Once the initial interviews are complete, participants will be invited to take part in two validation interviews, which will utilize the Validation Interview Guide Questions (Appendix M). The first validation interview, which will ask participants to review their individual narratives, will last approximately 30 60 minutes. The second validation interview, which will ask participants to review the common themes narrative, will last approximately 30 60 minutes.
- Due to the fact that it is difficult to predict the amount of time it will take to recruit all of the participants for the study and complete the second validation interviews, potential participants will be notified that their participation is expected for up to one year.
- The total time requested of the peer and expert reviewers will be up to 1.5 hours per reviewer over one year. This time includes the 30-minute validation interview to review the common themes narrative as well as up to 1 hour of reading and reflecting on the common themes narrative prior to the interview. Potential peer and expert reviewers will be notified that their participation is expected for up to one year to ensure that there will be enough time to complete the second round of validation interviews.

5.3 Reimbursements and Incentives for Participation

- Upon the first meeting with the student researcher, participants will receive a \$50 honorarium as compensation for their travel expenses and time at the beginning of the first interview.
- The peer reviewer will receive a \$20 honorarium after informed consent has been reviewed (see Appendix I) at the beginning of the face-to-face validation interview. If the validation interview is being conducted over the phone, a \$20 honorarium will be mailed to the peer reviewer after the student researcher has received a signed Informed Consent Form for the Peer Reviewer (Appendix I).
- The honorarium will be provided in the form of gift cards to Starbucks, Safeway, or London Drugs. The participants and peer reviewer will have the opportunity to tell the researcher what their preferred gift card would be at the end of the telephone screening conversation following the Initial Participant Contact Scripts (Appendices E & F). The participants and reviewer will be allowed to keep the gift card even if they withdraw from the study.
- The expert reviewer will not receive any gift or payment because of their professional duty of contributing to the advancement of society.

Rationale:

- Capacity to give fully informed consent will be determined at the time of screening and again during the process of informed consent before the interviews commence. Participants and reviewers will give full informed consent on their own behalf. Participants and reviewers will be emailed, faxed or mailed an invitation letter (Appendices C &D) and the informed consent form (Appendices H-J). After reading such information, they will be asked to reply and state if they agree or refuse to participate.
- Participants in the study will be of legal age and will be required to be comfortable completing up to five hours of interviews over a 12-month period as a criterion for the study before providing initial consent to participate. The peer and expert reviewers will also be of legal age and will be required to be comfortable completing one 30-minute interview up to 12-months as a criterion for participating in the study before providing initial consent to participate.
- The screening statements used in the Initial Participant Contact Scripts (Appendix E-G) will also be used to assess capacity before the first interview with each participant and the validation interview with the peer reviewer and the expert reviewer.

B. Ongoing assessment of capacity

How will capacity be assessed throughout the research if the participants' involvement goes beyond a single interview or completion of a questionnaire?

- The student researcher will assess the participants' capacity to provide informed consent for continued participation in the study each time that she meets with the participants. At the start of the first and second validation interviews the Informed Consent Form for Participants (Appendix H) will be provided to participants and they will be asked to give their verbal consent as an expression of their desire to continue participating in the study. Capacity to give consent will also include the assessment of any potential impairments (e.g. being under the influence of drugs and/or alcohol).
- If it seems plausible that any participant's capacity to provide continued informed consent is impaired, the student researcher will assess the participant's capacity to provide consent by asking the participant to explain what they consented to.

5.5 Explanation of Consent Forms to Potential Participants

How will the Informed Consent Form be reviewed?

- The Informed Consent Forms (Appendices H-J) will be emailed, mailed, or faxed to potential participants and reviewers following an initial telephone screening with the student researcher utilizing the Initial Participant Contact Scripts (Appendices E-G). The Initial Participant Contact Scripts (Appendices E-G) provide an overview of the research purpose and process.
- For potential participants, the Informed Consent Form (Appendix H) will be discussed thoroughly and potential participants will have the opportunity to ask the student researcher any further questions about the study before the audio-recorded initial interview begins.

Following this conversation, potential participants may choose to sign the informed consent form, thereby providing formal consent to participate in the study. - For the peer and expert reviewers, the Informed Consent Forms (Appendices I & J) will be discussed thoroughly and any questions that potential peer and expert reviewers have regarding the study will be addressed. If the peer and/or expert reviewer wishes to complete their validation interview in-person, they may choose to sign the informed consent form and provide formal consent to participate in the study at the beginning of the validation interview. If the peer and/or expert reviewer prefers to complete their validation interview over the phone, a signed informed consent form will need to be received by the student researcher prior to the start of the validation interview.
- For participants who signed the informed consent form at the beginning of their initial audio-recorded interview(s), a brief review of the informed consent form will take place at the beginning of both the first and second validation interviews. All electronic data (i.e. written interviews) will be stored for 5 years on 2 password protected USB drives. These drives will be placed in a locked filing cabinet when not in use. Hard copies of the data will also be placed in the locked filing cabinet for 5 years. The filing cabinet will be securely stored at the student researcher's home.

After 5 years, hard copies of the data will be shredded. Electronic copies will be erased. You will be able to keep the common themes narrative. The research findings will be published in a thesis document. The findings may appear in future publications.

<u>Limits to Confidentiality:</u> All identifying information from this study will be kept strictly confidential unless any of the following conditions are present:

- A) If a child or vulnerable adult is at risk of abuse or neglect and is unable to seek help, or is in need of protection.
- B) If you or another person is at clear risk of imminent harm.
- C) If I am required to comply with a legal order such as a court subpoena.

Risks and Benefits

By participating in this study, there is a small risk of experiencing stress. It is possible that you may feel discomfort through reflecting on your experiences. If you feel more stress than you would like, you can:

- 1. Decide not to answer a particular question.
- 2. Take a break from the interview.
- 3. Ask to reschedule the interview.
- 4. Withdraw from the study at any time.
- 5. Ask that your data be removed from the research up to 1 week after the validation interview has been completed.
- 6. Reach out to your support system.
- 7. Seek support from the resource referral list below.

Although aspects of this research may pose benefits, the intent of this study is not to provide personal counselling.

Benefits from participating in this study include experiencing validation and/or positive emotions. You may also gain new insights about your experiences. This study may benefit counsellors and other mental health professionals, including individuals employed in human resources, who work with recovered alcoholics who are employed full-time. It is possible that other individuals in recovery and their families may benefit from the research findings as they may gain a greater understanding of an AA member's work experience.

Appendix L: Orienting Statement and Interview Guide

Initial Check-In:

- "Now that we have reviewed the informed consent form, I have a couple questions to ask you before we start the interview."
- "How are you feeling about the interview today?"
- "Please note that any time, you may take a break, ask to reschedule the interview, or withdraw your participation from the study. Do you have any questions for me?"

"The purpose of this study is to explore the work experience of AA members with longterm sobriety. Earlier, you identified yourself to be such a person."

"Please consider your work experience while you were drinking and during recovery." The term work experience means your experiences relevant to your career such as professional development including education and experiences at the various jobs you have held." (I will pause and provide the participant with time to reflect.)

"I invite you to share your story of your work experience while drinking and while in recovery. I encourage you to tell your story as you understand it. I may ask you to elaborate or clarify parts of your story. However, please only share with me as much as you are comfortable with. My role will mostly be to listen."

"Please consider these two questions: "How has your sobriety impacted your work experience?" and "How has your work experience impacted your sobriety?" You may begin when you feel ready."

Throughout the interview, I may utilize the secondary research questions:

- "What AA principles did you use in your work environment and how did you use them?"
- "How did you handle similar situations while drinking?
- "How has your work experience changed throughout your sobriety?" (Probing question: "How has your length of sobriety affected your ability to handle work opportunities and challenges?")
- "What were the circumstances surrounding your decision and action to stop drinking?" (Probing question if needed: "For example, was your workplace or family involved in you going to treatment?") "How do you think this influenced your work journey?"
- "How have others' opinions of AA and alcoholics affected your career and your actions within the work environment?"
- "How do you think the severity of your drinking in the past influenced your work experience throughout your sobriety?"
- "What metaphor would use to describe your experience of working while being an AA member?" (If the participant asks for the definition or example of a metaphor, I will state "a metaphor is a phrase or idea that is used to represent something else. For example the phrase "bull in the china shop" could be used to represent one's work experience in early recovery".)

If the participant chooses to reschedule the interview or withdraw from the study at any time, the following script will be utilized:

- (If withdrawing) "I understand that you want to withdraw from the study. I understand that this is your right and I respect your decision. Please note that you have one month from today to tell me if you would like your data withdrawn from the study. I would also like to remind you of the resource referral list if you feel that you would like to speak with a professional about any distress you may be experiencing."
