Gator and Sam Teicher, co-founder, met and became friends at the Yale School of Forestry & Environmental Studies, where they both received Master of Environmental Management degrees. Their graduate studies and love for oceans inspired them to launch a company to solve global coral reef degradation. Through Coral Vita, they are restoring the world's dying reefs, which support up to 1 billion people through food, coastal protection and income. Halpern and Teicher were named one of Forbes' 30 Under 30 Social Entrepreneurs for 2018.
