



# **University of Delaware Charter**

- As codified into the Delaware Code of 1953, the Charter of the University of Delaware is in Title 14, Chapter 51, paragraphs 5101-5117. In paragraph 5111, the faculty receive their powers as follows.
- Par. 5111. Faculty; powers.

*The faculty*, consisting of the professors, instructors and others employed by the Board of Trustees, one of whom shall be President of the University, shall *have the care, control, government and instruction of the students*, subject, however, to the bylaws. They shall *have authority*, with the approbation of the Board, *to confer degrees and grant diplomas.* 



# **Role of Faculty** (3.2.1 Board of Trustees Bylaws)

- The BOT Bylaws organize the Board's committees and further define the faculty's powers
- Until otherwise ordered by the Board, and to the extent provided in these Bylaws, authority is hereby delegated to the University Faculty to formulate and administer the academic and educational policies of the University in accordance with the Charter of the University, provided that any changes in academic and educational policies having a material financial impact upon the University shall require approval of the Board



# **Privileges of the Faculty** (Section 3.2.6 Board of Trustees Bylaws)

*To make recommendations* to the President or the President's designee, for transmission to the Board, *concerning the formation of policies governing academic appointments, promotions, tenure, dismissals, and salaries.* 



## **Responsibilities of the Faculty** Section 3.2.5 Board of Trustees Bylaws


#### • Make recommendations

- on the *rules* and regulations for the government and discipline of the student body
- on educational and academic *policies of admission*
- concerning the establishment of any degree program or the disestablishment of any degree program
- Determine the *requirements for academic degrees*
- Consider and make recommendations for proposed changes in University organization.
  - Changes in University organization shall include the establishment or abolition of academic departments, colleges or divisions; the transfer of a department or division from one college to another; and the establishment or abolition of administrative offices that are directly concerned with academic matters

# **University Faculty Senate**

\*(College of Arts and Sciences has its own Faculty Senate)

- 62 elected Senators
  - 50 representing ~1250 faculty from all 7 colleges
  - 6 Exec, 4 Grad/UG Students, 2 librarians
- 12 ex-officio non elected Senators
  - President, Provost and 3 Deputy Provosts/Vice Presidents, 7 Deans
- Senate meets the first working Monday of the month during the academic year
- Hold open hearings on important issues
- Provide communications

  - Promote use of CANR organic foods and planting or native plants on STAR campus (Sept 2018)



## **Up and Coming Resolutions**

#### **Creation of a Graduate College**

#### May 2018 Passed Resolution:


RESOLVED, that the Faculty Senate intends to establish a Graduate College by January 1, 2019, contingent on passage of further resolutions by the Faculty Senate on or before that date approving (1) an organizational structure that shows relationships among the new Graduate College and existing graduate programs, departments, colleges, the Provost office, and research office, and (2) a draft version of By-laws for the new Graduate College. The organizational structure and draft Bylaws shall be drafted by an *ad hoc* Faculty Senate committee to be appointed by the Executive Committee of the Faculty Senate in consultation with the Provost no later than June 1, 2018.
