

Approved Interim Plan Recap

The interim plan was approved by the Consortium on May 9, 2024. Key areas of the plan include:

The Removal of the Christina School District from the City of Wilmington

• In any redistricting approach put forward, it is recommended that the Christina School District be removed from the City of Wilmington

Social Drivers of Health and Education Landscape Analysis for the City of Wilmington and Northern New Castle County, Delaware

• Facilitate social drivers of health and education needs assessment to examine the broader ecosystem around the implications of lived conditions that impact students and families before and after school

A framework for a final redistricting plan to include more detail on broad policy reforms related to revenue, state investment, and charter and choice reform.

Social Drivers of Health and Education Landscape Analysis Update

- June-July 2024: Redding Consortium leadership and staff convened a series of meetings to discuss the vision, goals, and scope of work for the landscape analysis.
- August 2024: Redding Consortium leadership team had two discovery meetings to discuss the project with state-approved vendors.
- The leadership team is currently in the process of vetting vendors to conduct the analysis and want to get consensus from the Consortium to support the leadership team's continued work.
- The goal of the landscape analysis will be to help to inform the work of the 3 subcommittees.



Subcommittee Membership

Three subcommittees include:

- Operational Impacts
- Fiscal Impacts
- Community Engagement
- Selection is based on Redding Consortium members' expressed interests, areas of expertise and experience, and community representation on the Consortium
- Appointees who are not members of the Consortium, such as school board members and district staff, have been placed on recommended subcommittees

The Redding Scholarship 2024-25 Application Process - Updates:

- Applicants submit only one application for the 2024-25 academic year
 This includes all coursework and course fees planned for the entire year
- Scholarship awards will not exceed \$10,000 per year per applicant
- DHEO reviewed applications under a competitive scholarship review process

Boost '26 Program: Data Project Update

Boost '26 was created to promote cross-district collaboration between the five northern New Castle County public school districts and provides graduation coaches to directly support city of Wilmington students to improve graduation rates.

Community in Schools (CIS) graduation coaches work to provide holistic support for 2-3 years with the cohorts of students enrolled in the program across the participating schools.

The Institute for Public Administration is currently analyzing the student data collected from the Data Service Center to:

- Assess student performance across the Boost 2022 and Boost 2023 Cohorts
- Evaluate the effectiveness and efficiency of the CIS graduation coaching support
