University of Delaware shall at all times have complete supervision, direction and control over the services of performers on this engagement and expressly reserves the right to control the manner, means and details of the performance of services by the performers including the leader as well as the ends to be accomplished.

Artist agrees to indemnify and hold harmless the University and its trustees, directors, officers, managers, employees, agents, clients and representatives from and against any and all claims, damages, losses and expenses including, without limitation, reasonable attorney's fees arising out of or in any way resulting from the negligent or intentional acts or omissions of the Artist under this Agreement.

The validity, construction, and effect of this contract shall be governed by the policies of the University of Delaware, and by the law of the State of Delaware. Contracts between a Registered Student Organization and an Artist or outside agency must be reviewed and approved by an Assistant Director for the University Student Centers or designee. **No Student is authorized to make a contractual agreement with an outside agency or artist.**
