- Tractor Supply in Middletown is having their 4-H paper clover drive from April 24 through May 4<sup>th</sup>.
- The State Program Leader position is in the interview process with two very strong candidates.
- The State Teen Council is hosting an inaugural Spring Formal Dance at the Vanderwende Farm event facility on April 13<sup>th</sup>.
- The DE 4-H Foundation is continuing to receive nominations for the 2024 Laureate Class. Deadline has been moved to May 1.
- The LifeSmarts competition has the Sussex County team going to the National LifeSmarts Conference. This LifeSmarts competition is expected to grow in the coming years.

#### Old Business:

- State Camp and Day Camp registrations are open. State Camp is 68% full and NCC Day Camp is full. Registrations will open to the public on April 1<sup>st</sup>.

- 7. April 6 is the annual Spring 4-H/FFA Dairy Show on the show grounds at the Delaware State Fair.
- 8. April 13 is Camp Barnes Clean-up day
- 9. The Clothing Showcase will be on April 14 at the New Castle Building at the Delaware State Fair. All construction items and ready to wear items need to be at the NCC office by April 8<sup>th</sup>.
- 10. April 19 is the deadline for the Litter Barrel contest participants to have their barrels in place. If a club is in need of a barrel, let the NCC 4-H office know.
- 11. National 4-H Conference will be April 19-24<sup>th</sup> in Washington, DC. There are three Delaware 4-Hers attending.
- 12. The Health and Wellness Ambassadors (HAWA) are having an overnight training event from April 19-20.
- 13. April 21<sup>st</sup> will be the County Archery Shoot at B&B Farms in Townsend from 2pm-4pm.
- 14. All hands on deck for our next Ag Day event on Saturday April 27<sup>th</sup>. This is our biggest fundraiser for our leaders organization. Brenda Shaffer continues to be the (magnificent) leader of this event for us with organizing needs and gathering/delegating all the necessary items for our Food Booth. We are also going to have the NCC Links sell Pulled Chicken (with final approval forthcoming) as a fundraiser vehicle since there will not be a NCC Livestock Show this year.
