This document is a compilation of government reactions to the International Law Commission's Draft Articles on Crimes Against Humanity during the United Nations General Assembly Sixth Committee's 78<sup>th</sup> Session and notes country support for the 2019 ILC Draft Articles on Crimes Against Humanity during the meetings of the Sixth Committee on 11<sup>th</sup> and 12<sup>th</sup> October 2023. My delegation strongly encourages that we proceed to rigorous national inquiries and mobilize the means and take the time in order to establish irrefutable evidence.
