



### **Department of Homeland Security Waiver Acting DHS Secretary Duke** \* Calexico, CA \*



- cover 102 out of 167 miles of California's border with Mexico (61%)
- \* "legacy" fences were those constructed before the Secure Fence Act of 2006; fence types as mapped here are based on data from the Department of Homeland Security as of October 2013; the pedestrian fence east of the Calexico Port of Entry appears to have been replaced
- since this time \* PF70 = primary (pedestrian) fence relatively easy and pre-planned fencing
- put up shortly after the Secure Fence Act passed \* pedestrian barriers are generally found
- close to urban areas and relatively accessible rural locations; all fencing mapped here is pedestrian fencing
- \* vehicle barriers generally require less disturbance and allow greater passage of wildlife; this fence type tends to be found in more rural locations; the nearest segment to Calexico is 11.5 miles west of the POE
- \* CBP frequently "voluntarily" complied with waived laws under the Obama




