## THE MORGAN L. ALLISON - WAYNE N. HIATT AMPHITHEATER



On May 12, 1990, Dorothy Elliott was the first patient operated in the newly renovated amphitheater during a continuing education course on implants. The amphitheater was not quite completed, but it was a delight to work in absolutely luxurious surroundings.

This is to announce that the Allison-Hiatt Amphitheater has become a reality. As you know, the amphitheater was renovated using theater seats instead of benches, new cabinets, lighting, a separate and independent suction system, air conditioning unit, and television monitoring equipment.

Just as the initial use of this room was for continuing education, we fully intend to use this theater for as much continuing education purpose as we possibly can. The physical arrangement will also allow this surgical theater to be used as a seminar room for groups up to about thirty.

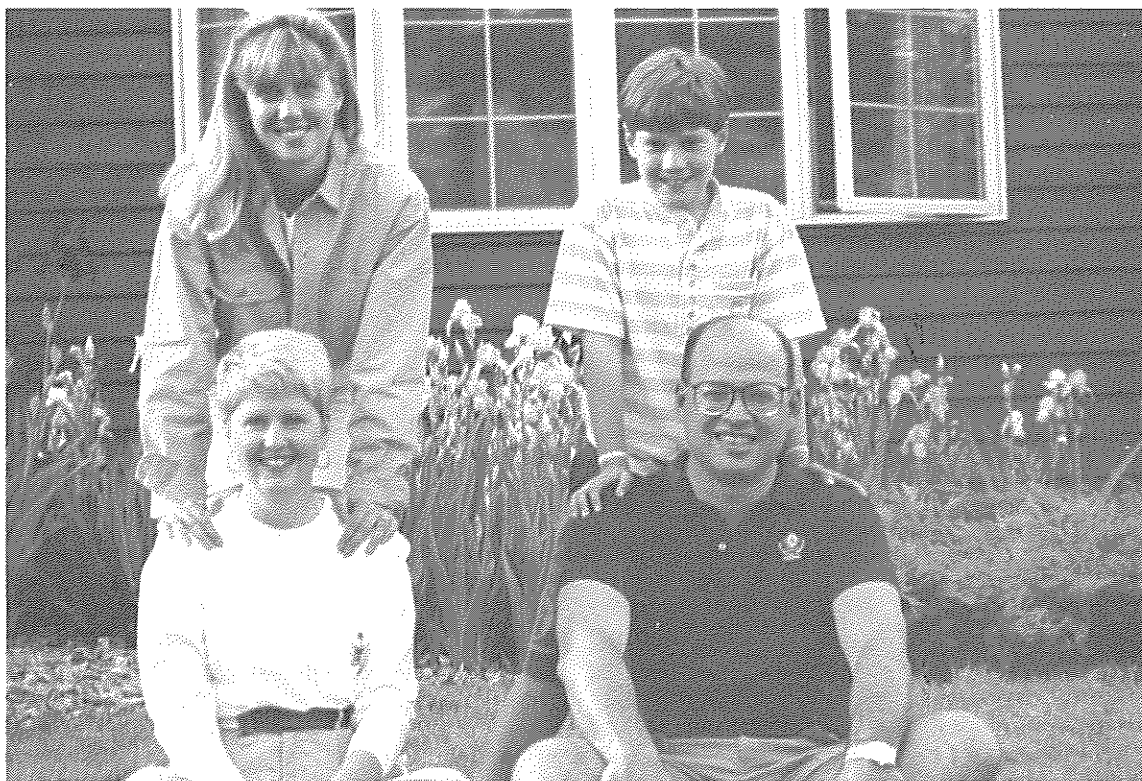
We intend to do clinical trials with the use of new anesthetic drugs as well as with new surgical techniques. Joel Weaver will be doing anesthesia for severely handicapped patients for whom hospitalization for restorative work under general anesthesia is not possible, or may not be warranted.

Another dose of good news is that

the construction cost were actually LESS than originally anticipated, and there has been money left over to buy some of the equipment which we hoped to purchase. This has included the surgical chair, an x-ray unit, an independent suction system, and the television monitoring equipment which is located overhead for close-up visualization of the surgical field. The headlight-mounted television camera which will feed these monitors has been purchased with money from a grant from private industry. This camera was relatively expensive, and through some good fortune and hard work on the part of Peter Larsen, Tim Conley, and the oral and maxillofacial surgery residents, the residual funds from this project were available for this camera.

All in all, I am extremely delighted with the results of everyone's efforts. As I travel around the country and tell people about our new amphitheater and the fact that the money was contributed by alumni of this program, I am met with expressions of disbelief. I am absolutely convinced that nowhere in the United States is there an oral and maxillofacial surgery alumni group as supportive as the Morgan L. Allison Society of Oral and Maxillofacial Surgeons. Congratulations to all of us for making this possible.

## FROM THE CHAIRMAN



The Oral and Maxillofacial Surgery Training Program at The Ohio State University is certainly alive and well. The clinical training for our residents is extremely broad-based, and is of sufficient quantity that each resident has the opportunity to experience the growth in surgical judgement and maturity which are the hallmarks of an excellent surgeon.

In addition, and as important from the point of view of a truly outstanding training program, our residents have been heavily involved in academic and research activities. All three senior residents this year have been involved in research projects which have lead to master's degrees. In addition to the obvious benefits of increased knowledge for the individual as well as for the oral and maxillofacial surgery community, these projects provide the resident with additional opportunity for travel. Five of our residents went to the annual AAOMS in September in San Francisco where they presented papers. In addition, three of them presented papers at the International Association of Dental Research annual meeting in March of this year. Mark Wohlford won the Walter Lorenz Award at the annual IADR meeting. This cash award of \$1000 is given to the young investigator presenting the best oral and maxillofacial surgery paper.

The exchange program with Sunderland, England continues to be a highlight of our training program. Bill Purdy went to Sunderland in the springtime of last year, and Larry Towning and Andy Loetscher each spent three months there this year. We had only a single visitor from there, Colin Harrop, who spent the month of March with us. Scott Hum and Jim Amborski will each be spending three months in England in the upcoming year, and there will be several registrars who will be spending several months with us in return.

The off-service clinical rotations have remained relatively stable over the last four or five years, with the single exception that a rotation on the Neurosurgical Service has replaced the rotation on the Surgical Intensive Care Unit. Due to the fact that the new Chair of Neurological Surgery is very favorably predisposed to oral and maxillofacial surgeons, this rotation has turned out to be an excellent one for us.

This June, three residents leave us after completing their four years of training. Larry Towning, Bill Purdy, and Andy Loetscher have been a strong force in our program for the last several years. As a class, they have exemplified the very best that the term "oral and maxillofacial surgery resident" implies.

Bill Purdy will move to Vermont to join the practice of John Farnham in Burlington. Bill is originally from the Northeast, and will feel as though he is returning home when he arrives there.

Andy Loetscher will be jointing the practice of a former resident of this program, James Sparks, in Atlanta. He is looking forward to starting a new life in a new area of the country.

Larry Towning will stay in Ohio, and has chosen to continue his education by completing a medical degree at the Northeastern Ohio Universities College of Medicine. If everything works out as planned, he should be able to complete his degree and a year of internship in approximately two and one-half years.

The new chief residents will be Scott Hum and Jim Amborski. They are primed and ready to take over the leadership reins of this program. While they will have to do work that three chief residents did last year, I am sure that they will manage the job without difficulty.

Mike Stronczek and Mark Anderson will be our new third year residents. They have been off-service almost the entire year, so it will be great to have them back on-service and rejoining the oral and maxillofacial surgery community.

Our three new second year residents, Rick Urbanek, Tom Baransky and Todd Liston will be leaving us for a year of off-service rotations after having an easy introduction into the sweet life of oral surgery.

We will be welcoming two new interns this year, Allen Herpy and Cynthia Trentacosti. Like Scott and Jim, they will be taking over the duties that were formerly done by three residents, but I am sure that they will be totally capable of handling the job.

The Dental Anesthesiology Program will welcome a new resident, Joe Seay into its first year position. Roger Fleser will be the second resident.

This year the department has a "teaching fellowship." This position was designed to provide an expanded opportunity for someone looking to become an oral and maxillofacial surgery resident. The term, "oral surgery intern" did not quite describe the activity of this position, although it functionally turned out to be. Tim Conley occupied this position during the past year. He is a 1989 graduate of The Ohio State University, and will commence his oral and maxillofacial surgery training in Galveston, Texas on July 1, 1990. He served many functions in our department over the past year, including a major effort on a research project with Peter Larsen. In the 1990-1991 year, Joe Cieslak will fill this position. Joe also is an Ohio State graduate, and is looking forward to an oral and maxillofacial surgery training program in the following year.

During the winter quarter, we had the opportunity to have a first year dental student spend the entire quarter with us. Jaleh Keyhani served as an oral surgery clerk during this quarter. She assisted at surgery in the clinics and the operating room, as well as served as a research assistant on a number of projects. Her participation in this activity confirmed in her mind that she will eventually apply to an oral and maxillofacial surgery training program.

We also had a visitor from Dr. Minoru Yamaoka's program in Tokyo, Japan. Dr. Tomoaki Murata spent six months with us participating in a variety of surgical procedures and conferences, in our operating rooms and clinics. Dr. Yamaoka has sent other junior faculty to visit us in the past, and we hope that this will happen again in the future.

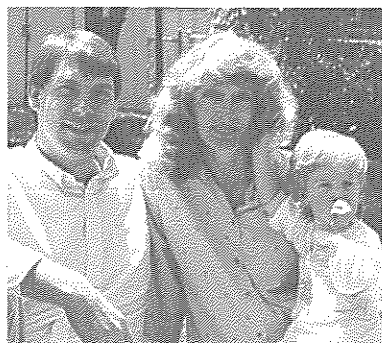
In the 1990-1991 academic year, we already know of several visitors who will be spending time in our department. Dr. Francisco Marchesani from the University of Concepcion in Chile will spend two months with us studying implantology. Dr. Hans Haanaes, Chairman of the Department of Oral Surgery and Oral Medicine at the University of Oslo in Norway, will spend a portion of his sabbatical leave with us in the fall. Dr. Haanaes will be working on a research project dealing with the use of soft lasers in the area of nerve regeneration. In addition, we also expect that we will have a visitor or two from other Asian countries. We receive a large number of inquiries from this area, and we anticipate that we will continue to host these visitors.

As you will note in this addition of the Tira Dentes, Dr. Arden Hegtvedt from the University of North Carolina will be joining the full-time faculty. I believe, that his presence on the faculty will have a significant impact, both in our research activity as well as in our oral and maxillofacial surgery training program.

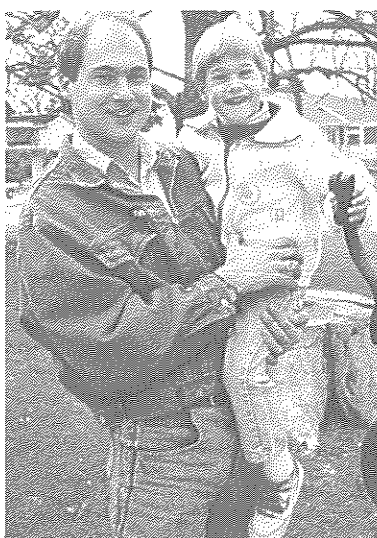
## TO OUR DEPARTING RESIDENTS - WE WISH THEM THE BEST

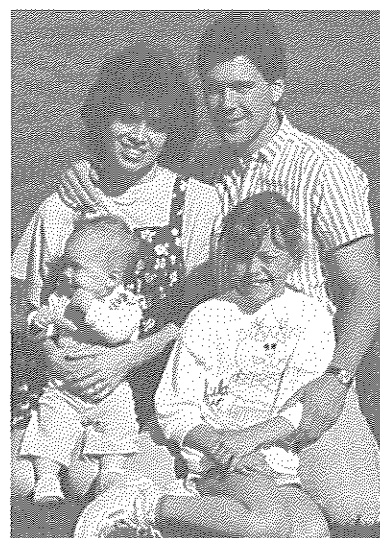
**ANDY LOETSCHER**

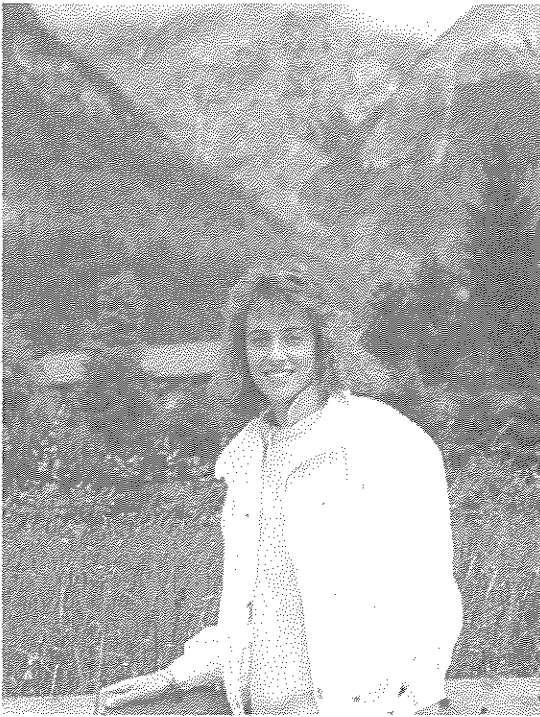

**ALLEN K. HERPY**

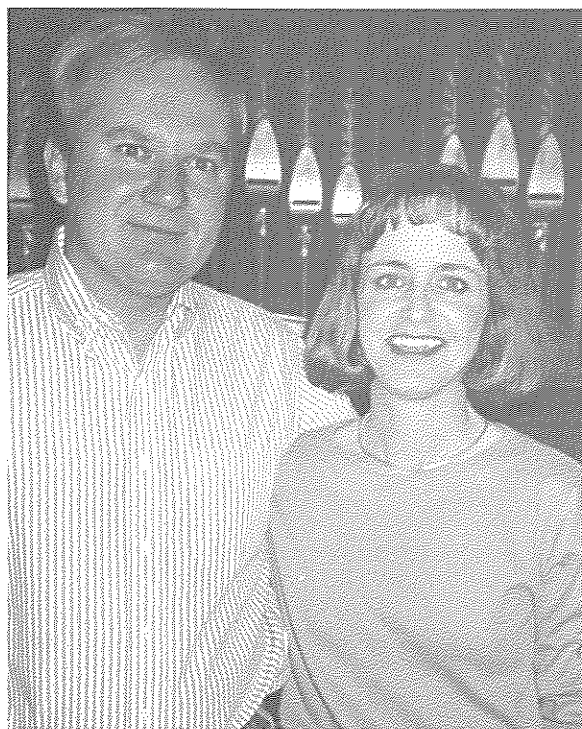

**JOSEPH P. SEAY**

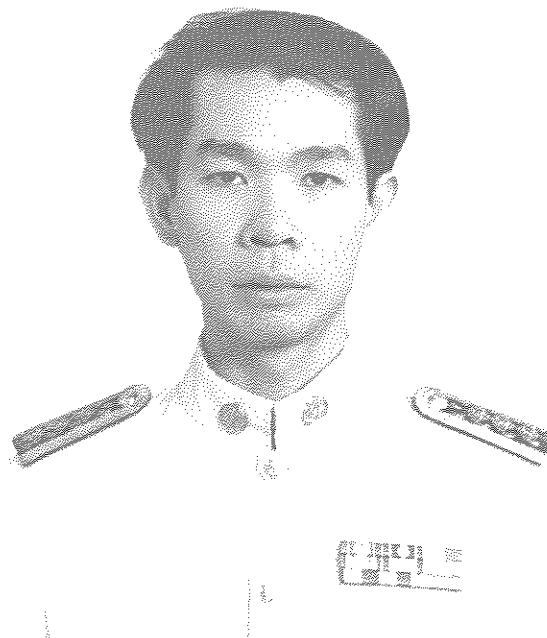

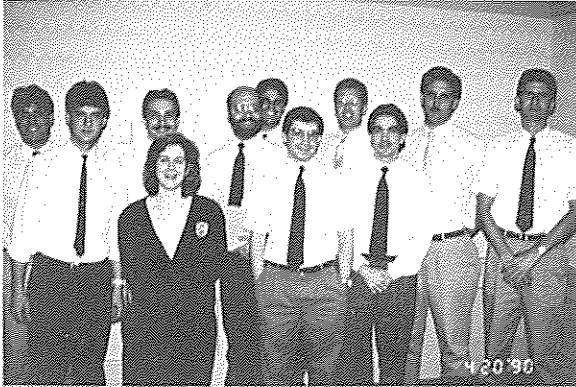
Narong returned to Bangkok in late March of 1990 and we wish him well in his career. We will miss his captivating smile.
