All applications are to be completed by the applicant, signed by a parent/guardian and their Youth Organizational Advisor, then returned to the Ohio State University Extension Office (see address below). All members of the Junior Fair Board must have been members of their respective organization for at least one year preceding their election and shall continue such activity while serving on the Board.

Qualifications:

- At least 13 years of age and NOT have reached their 19th birthday as of January 1st of the year serving.
- Some experience required, either as a previous Junior Fair Board member or a Junior Fair Exhibitor.
- Ability to work with minimal supervision and/or know when and where to receive assistance when needed
- Demonstrates appropriate behavior at all times
- Possess good leadership abilities and responsibility skills
- Willingness to promote the Junior Fair as an educational opportunity where proper ethics and honesty is valued
- Supports the Junior Fair Board as an active, productive organization by:
 - Attending meetings regularly – complying with respective Junior Fair Board’s attendance policy
 - Complying with the respective Junior Fair Board’s constitution
 - Being involved in the youth organization in which they represent

Responsibilities:

- Plan and conduct your department activities and assist when needed in all events that are part of the Junior Fair
- Search for methods and programs to improve Junior Fair activities/events
- Contact and secure award sponsors/donors as needed
- Always maintain a professional attitude when handling Junior Fair participants, advisors, and parents
- Keep accurate records of Junior Fair Board meetings, shows, and Junior Fair activities
- Work closely with adult leaders (committee members, Senior Fair Board members, etc.) by sharing in the planning and conducting of department rules and activities
- Read, understand, and enforce the general rules and the specific rules applying to your department and Junior Fair
- Assist in operating the Junior Fair Board Office
- Understand that all Junior Fair Board plans, rules, schedules and activities are subject to Senior Fair Board approval
- Assist Senior Fair Board and committee members as needed
- Assist Extension staff, Agricultural Education instructors, and other youth
- Promote the Junior Fair as a positive educational opportunity for youth to exhibit
