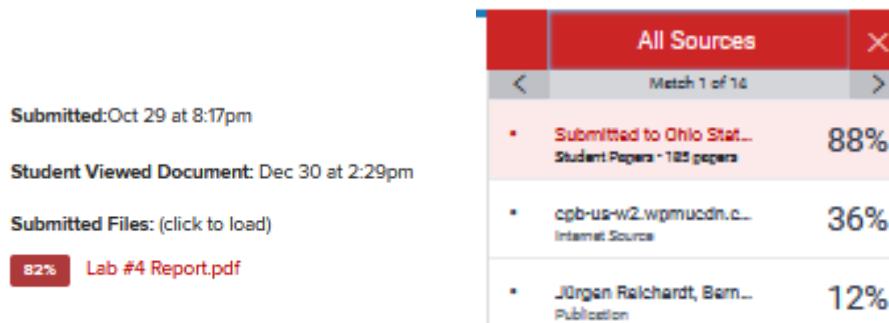

- Your lowest *lab report* grade will be dropped. ***NO lab checkpoints are dropped.***
- ***If you do not attend a lab or make up the missed lab section, you are not eligible to submit a lab report., You will receive a grade of 'zero' for both the Checkpoints and the Lab Report. Your lab partners are still required to submit a report but only they will be graded for the lab.***
- There is no midterm or final examination for the lab portion of the course.

## PLAGIARISM

- Plagiarism is the act of submitting written academic material, that you are representing as your own work, when it is actually copied, in part or in whole, from another person's written work. This can be another lab group, an individual, or copies of course material from the instructor or professor.
- You should be aware that there is a **Turnitin™** software application that compares every submission in the laboratories to previously submitted documents, lab instructions, and documents that have been posted on the internet (e.g. CourseHero). This application reports the percentage of your document that matches documents as far back as 10 years. Because there is a good deal of commonality in laboratory reports, it is not unusual to have a 40-50% commonality with previous submissions. A plagiarized lab report rating from **Turnitin™** appears below.



### 3. Button Debounce circuit with Stretch Timer schematic

Open the latest SimonGame project that has the button debounce circuit. Create the stretch timer and stretch counter in the ButtonDebounce block diagram file. In order to observe the effect of the pulse stretch timer, set the comparator value of the Stretch Timer to have a delay of one second. Do this by setting the constant value in the Stretch Compare megafunction to 48000. Update the symbol file and delete and replace the old Button Debounce symbol at the top-level. Connect the AUD\_DACLRCK to the clock input of the new Button Debounce symbol. Connect the Simon Box to the DE2 board. Compile and program the project with the modified debounce circuit. Observe the one second delay when you press the buttons. Calculate the correct comparator value to set the pulse stretch delay down to 150 milliseconds. Recompile the schematic, update the symbol, and, again, replace the block on the top-level schematic.

- You may work in Lab Groups of two or three students.
- **Checkpoints:**
  - **YOU MUST VERIFY THAT ALL OF YOUR CHECKPOINTS ARE RECORDED IN THE NOTEBOOK PRIOR TO LEAVING THE LAB.** *You must SIGN the Checkpoint Sheet as part of the last Clean-up Checkpoint. By this action, you are agreeing that the Checkpoint sheet is correct.*
  - **YOU CANNOT Receive CHECKPOINTS after leaving the lab session.**

- **You are permitted to make up one missed lab per semester.**
  - **Exception:** MIDTERMS AND OTHER TESTING CONFLICTS ARE NOT PERMITTED BY THE UNIVERSITY AND MUST BE RESOLVED BY YOUR PROFESSOR SHOULD THEY SCHEDULE TESTING DURING YOUR ENROLLED LABORATORY TIME. YOU WILL NOT BE PERMITTED TO MAKE UP A LAB TO ATTEND A MIDTERM. YOUR PROFESSOR IS REQUIRED TO OFFER YOU AN ALTERNATE TIME IF THEY SCHEDULE A MIDTERM DURING YOUR LABORATORY MEETING TIME.
  - Make-up labs cannot be performed any later than ***Friday November 22<sup>nd</sup>.***
  - ***Your GTA will schedule the make-up lab. It is best to make up the lab before your next regular lab session, or you will fall progressively behind in the lab sequence.***
