Due Jan 31, 2020: [The University of Chicago Center for Global Health \(CGH\)](#) is an interdisciplinary Center dedicated to improving health and well-being through education, research and training, and advocacy in partnership with communities in the United States and around the world. [The CGH Summer Research Fellowship](#) is a funded, 10- to 12-week, global health experiential learning and research opportunity for undergraduate and graduate students. The objective of this Fellowship is to provide students at different levels and from various academic disciplines practical exposure to global health and policy research with a strong foundation in faculty and peer-to-peer mentorship.
