GPHAP Students Win 1st Prize in Henrietta Lacks Health Equity Case Competition!



A team of GPHAP students won 1st prize at this year's [Henrietta Lacks Health Equity Case Competition!](#) The team was composed of Julia Higgins, Harris; Rachel Huynh, Booth (a friend of GPHAP); Diego Mendoza-Martinez, Harris; and Kate Sohn, Booth. The case competition is sponsored by The University of Michigan Ross School of Business in Ann Arbor and was held on Feb 17. The event is inspired by the life of Henrietta Lacks, whose cancer cells – code named HeLa – were taken without her knowledge in 1951. They became one of the most important tools in medicine—with damaging consequences for her family, many of whom often struggled to get access to the very health care advances their mother's cells helped make possible. The Henrietta Lacks Health Equity Case Competition strives keep the spotlight on racial health disparities. Its goal is to encourage future health care leaders to address health issues that are challenging communities of color. Teams don't know the topic in advance. The topic was released one week before the case competition and the teams had one week to work on the case. This year's case topic was on how to

Medical mistakes are more likely in women and historically underrepresented groups: Hundreds of thousands of U.S. patients are harmed or die each year because of diagnostic errors. Around 12 million adults in the US are misdiagnosed each year, which can lead to serious harm. Women and people from

underrepresented racial and ethnic groups are up to 30 percent more likely to face [diagnostic errors](#) than white men.
