

The Urban Institute released its findings from a study that looked at the resettlement of Afghan evacuees to the U.S. after their evacuation from Kabul. Data collected for the study included in-person interviews with Afghan evacuees and virtual interviews with a broad range of community stakeholders across three sites: Chicago, Illinois; northern Virginia; and San Antonio, Texas. Community stakeholders included resettlement agency staff, community-based organization staff, school administrators, employers, medical professionals, sponsors, landlords, legal providers, faith leaders, veterans, local government staff, and volunteers. Two of the report authors, a member of the project's community advisory board, and three field interviewers who are also Afghan will engage in a roundtable discussion focused on the community-based research methods utilized in this study, lessons learned and reflections on process. The report examines the experiences of 36 Afghan evacuees and how they fared a year and a half after arriving in the United States and how the broader community and resettlement infrastructure in three study sites-Chicago, northern Virginia, and San Antonio, responded to their complex needs. The report concludes with lessons that can inform a framework of proactive policies that better prepares the US government, resettlement agencies, and other groups to meet the needs of people more cohesively during humanitarian crises. For more than 160 years, federal, state, and local governments in the U.S. have invested heavily in public health and healthcare services. Yet throughout history, our taxpayer-supported healthcare architecture has remained mostly hidden from the public behind the veneer of a predominantly private system. How did this happen?

Jamilia Michener and Alfredo Morabia, renowned experts on Health Equity, Health Policy and Public Health, will discuss Grogan's new book Grow and Hide: The History of America's Health Care State. Grogan's sweeping history of the American healthcare state explains how and why the grow-and-hide phenomenon arose and details the consequences we've all felt.

The Fight for Black Lives is a documentary by UChicago Professor of Comparative Human Development and CSRPC Faculty Affiliate Micere Keels. The film chronicles the ways that racial stress and the American healthcare system disadvantage the health of Black Americans. The film weaves together stories of women who were pregnant during the pandemic and Black Lives Matter uprisings, interviews with Black health experts, and historical records to show the many ways that Black women have had to fight for their life and the lives of their infants in the delivery room. These health disparities start at the very beginning of life and the most

shocking aspect of this is that the likelihood that Black newborns will die relative to White newborns is higher today than it was in 1900.

Standing Up for Science: A Communication Playbook for the Next Health Emergency by Lindsey J. Leininger, PhD

Clinical Professor of Business Administration, Tuck School of Business, Dartmouth

Lindsey J. Leininger specializes in data-driven health policy, with a focus on the health care safety net and community health. She has a longstanding interest in publicly funded health insurance programs, with related research spanning quality measurement, risk segmentation, and program evaluation. Her community health work focuses on health education and promotion initiatives. Highlights include leading an award-winning crisis communication campaign during the COVID-19 pandemic; designing and delivering a nationally recognized curriculum for public benefits navigators; and leading the data and research efforts for a home-visiting program for high-risk pregnant women in Wisconsin. At Tuck she teaches courses on data-driven decision-making in the health sector. She also serves as Faculty Director for the Center for Health Care. Prior to Tuck, Lindsey spent a decade designing and leading research and technical assistance projects for Medicaid agencies, both as an academic and as a think-tank researcher.
